**Multi-Capture Structure Changes:** Changes made to use standard SAP CCAUT\_R structure for multi-capture workflow to avoid errors if it contains appended values.

#### 3.3.1 Problems Addressed

**Repeat Settlement:** Changes were made to address errors occurring when running Repeat Settlement with certain processing parameters.

#### **Compatibility and Basic Requirements**

The following is applicable for both 3.3.0 full and 3.3.1 patch release.

- SAP ECC 6.0, ABAP 702 Support Pack 0018 minimum
- Paymetric SAP components:
  - PAS 2.10.0
    - NOTE: This release should be backwards compatible back to PAS 2.8.0; however, it was tested with 2.10.0. If you are implementing tokenization through TMS, 2.10.0 minimum is required.
  - XiSecure SAP ECC IK 3.5.0

## **Install and Configuration Notes**

#### **New Installs**

Version 3.3.0	Install this full transport first.
Version 3.3.1	Then install this patch transport which has a fix related to running the Repeat Settlement program.

Refer to the XiPay Platform SAP ECC Integration Guide for install, setup, and integration details.

#### **Upgrades**

If you are on a version prior to the latest full transport, install the full one and all subsequent patch transports.

- If you are on a version later than the latest full transport, verify all patch transports between your version and the latest are installed before installing the latest.
- For ALL upgrades, even if PCMA IMG modifications are not required for the upgrade, you must execute the PCMA IMG transaction code (/n/PMPAY/PIMG) to initiate the objects from the upgrade.
- When importing the transport(s):
  - The 'overwrite existing objects' flag should be selected since many of these are existing objects.
  - Allow sufficient time for each transport to complete before loading the next one to prevent syntax errors.
- Any custom changes (including userexits configured in the PCMA IMGs) should be evaluated and may need
  to be replicated in the new later versions of these userexits. There may be new userexits that were not in your
  previous version please review the documentation for details.
- If upgrading from a previous/older version of PCMA, it is advised you recreate any custom userexits that are configured in /PMPAY/PIMG. They should be recreated based on the new sample default userexits that are provided.
- As always, please test thoroughly before moving to PRD. If you would like to obtain consulting assistance with this install, please contact <u>Support Services</u>.
